- Ends on a note of promised restoration—**but only if Job is innocent.**

Core Message of Bildad:

- God is perfectly just and never punishes the innocent.
- All suffering is proportionate punishment for sin (either Job's or his family's).

- Repent, and prosperity will return; refuse, and you prove you're godless.

Tone:
